# JANUARY 5, 2011 -- Fire Hall -- 6:00 PM

The 2011 Organizational Meeting of the Kingsville Township Trustees was called to order at 6:00 PM by the Fiscal Officer, Deborah Ball. The Pledge of Allegiance was said. Present were Mr. Darrell Ensman, Mr. Dennis Huey and Mr. Doug Reed. Nominations were open for Chairman. Mr. Reed nominated Mr. Ensman to serve as Chairman for 2011. Mr. Huey seconded the nomination; on the call of the roll: Mr. Ensman - Yes; Mr. Huey - Yes; Mr. Reed – Yes. At this time, Mr. Ensman moderated the meeting. Mr. Reed nominated Mr. Huey for Vice Chairman; motion seconded by Mr. Ensman; on the call of the Roll: Mr. Ensman - Yes; Mr. Huey - Yes; Mr. Reed - Yes.

REAPPOINTMENTS: Mr. Huey made a motion to table the Zoning Board of Appeals and Zoning Commission reappointments until the next regular business meeting while they determine which positions are at end of term and contact potential nominees; Mr. Ensman seconded that motion; all yes. Mr. Ensman made a motion to reappoint Mr. Jim Branch as Zoning Inspector - annual term to expire 12/31/2011; Mr. Reed seconded the motion; all yes.

### FEES:

Zoning / General: Mr. Huey moved to keep, for 2011, the zoning permit fees unchanged: \$35 residential, \$50 residential new construction, \$200 commercial, \$100 commercial sign only, \$125 for a residential variance hearing, \$250 for a commercial variance hearing and \$500 for zoning text or map amendments/changes, and also for 2011, to keep the copy fees \$.25 per page of copies for all general and zoning related records; motion seconded by Mr. Reed; all yes.

Road: Road Bond Application Fee for 2011 will remain \$25

Cemetery: Mr. Ensman moved that all cemetery fees remain unchanged except for the change in the fees for an urn vault from \$75 to \$100 for 2011: Motion was seconded by Mr. Huey; all yes.

2011 Fees: Graves for Twp Residents \$200 each - Non-resident is \$350.

There will be no pouring of foundations until we have a minimum of 7 yards and if someone demands a pouring of the foundation when we do not have a minimum of 7 yards, they must pay all material and wages for the pouring. The person ordering veteran's marker must pay foundation fee prior to setting. Special or extenuating circumstances need to be discussed with the Cemetery Sexton.

**Copy Fees:** Mr. Reed made the motion that the fee for any Accident/ Fire/ EMS/ or related report/records request that is not a Fiscal Officer record will remain \$25 per report/record; Mr. Huey seconded the motion; all yes.
