Foundations - \$12.00 per cubic foot **Deed transfers** - \$35.00

There will be no pouring of foundations until we have a minimum of 7 yards and if someone demands a pouring of the foundation when we do not have a minimum of 7 yards, they must pay all material and wages for the pouring. The person ordering veteran's marker must pay foundation fee prior to setting. Special or extenuating circumstances need to be discussed with the Cemetery Sexton.

Neal Stewart would like to send 4 fire fighters to a First Responder Class at a cost of \$450.00 per person minus the cost of the books that have been ordered because they are needed before the first class. This class is done through the Vo-Ed School but they will be hosted by Monroe Township. Doug Reed made a motion to allow 4 fire fighters to go to these classes at a cost of \$450.00 minus the cost of the books. Dennis Huey seconded the motion; all yes.
