***Cost of vault for urn is \$125. ** No Cremations on Saturday unless there is full funeral services. Grave Openings are to be completed no later than noon on Saturday. No holiday grave or cremains openings. Weekdays they need to be done at cemetery by 3:00 pm and Weekends by 10:30 am or they will be charged \$150.00 overtime fee**

Exhumations – week days only - \$1,500 **Cremated vault/ashes** - \$300.00
Foundations - \$12.00 per cubic foot
Deed transfers - \$35.00

There will be no pouring of foundations until we have a minimum of 7 yards and if someone demands a pouring of the foundation when we do not have a minimum of 7 yards, they must pay all material and wages for the pouring. The person ordering veteran's marker must pay foundation fee prior to setting. Special or extenuating circumstances need to be discussed with the Cemetery Sexton.

Doug Reed made a motion to have the cemetery fees remain the same for 2014 and have the fiscal officer send prices to the funeral homes with all of the information above listed. Darrell Ensman seconded the motion; all yes.

MILEAGE REIMBURSEMENT:
