The 2016 Organizational meeting was called to order by Sarah Patterson, Fiscal Officer, followed by the Pledge of Allegiance. At that time the fiscal officer turned the meeting over to Dennis Huey, Chairman.

Carol Brunell, notary and mother of Karl Brunell, gave the oath of office to Karl Brunell as newly elected Kingsville Township Trustee and Sarah Patterson, reelected Fiscal Officer.

Dennis Huey made a motion to approve a resolution to put back \$26,080.16 to the general fund from the road and bridge fund that was paid in error for a vehicle payment in 2013 that was noticed during the 2013 and 2014 audit that was completed at the end of 2015. Darrell Ensman seconded the motion. On the call of the vote: Dennis Huey - Yes and Darrell Ensman - Yes.

The trustee asked the fiscal officer to put a motion in the Star Beacon for the next regular meeting to be held on Wednesday, January 13, 2016 from 7:00 pm to 8:00 pm.

Election of Board Chairman: Dennis Huey made a motion to elect Darrell Ensman as Board Chairman for 2016, Karl Brunell seconded the motion; all yes.

The meeting was turned over to Darrell Ensman, Chairman.

Darrell Ensman made a motion to reappoint Jim Branch and Neal Stewart to a one year term to Zoning Inspector and Fire Chief respectfully. Dennis Huey seconded the motion; all yes.

No holiday grave or cremains openings. Weekdays they need to be done at cemetery by 3:00 pm and Weekends by 10:30 am or they will be charged \$150.00 overtime fee.

Exhumations – week days only \$1,500 **Foundations** – \$12 per cubic foot.

There will be no pouring of foundations until we have a minimum of 7 yards and if someone demands a pouring of the foundation when we do not have a minimum of 7 yards, they must pay all material and wages for the pouring.

The person ordering veteran's marker must pay foundation fee prior to setting of marker. Special or extenuating circumstances need to be discussed with the Cemetery Sexton.

Dennis Huey made a motion to keep all cemetery fees the same for 2016 but add to the rules sent to the funeral homes and monument companies that all orders for footers would need to turned into the Sexton 30 days prior to Memorial Day. Karl Brunell seconded the motion; all yes.

The trustees asked the fiscal officer to make sure notices with pricing and rules be sent to the funeral homes and monument companies.

Regular Meetings: Darrell Ensman made a motion to keep the regular meetings on the 2nd and 4th Wednesdays at 7:00 P.M. Dennis Huey seconded the motion; all yes.

Mileage Reimbursement: Dennis Huey made a motion to keep the mileage reimbursement at \$.54 per mile. Karl Brunell seconded the motion; all yes.

Firefighter / EMT / Paramedic Roster for 2015: Neal to present this to the trustees at the regular meeting.

Dennis Huey made a motion to go into Executive Session to discuss wages for 2016. Darrell Ensman seconded the motion. On the call of roll: Darrell Ensman – Yes, Karl Brunell –Yes and Dennis Huey – Yes.
