

KINGSVILLE TOWNSHIP TRUSTEES REGULAR

MARCH 28TH, 2007 - 7:30 pm – FIRE HALL

The regular meeting of the Kingsville Township Trustees was called to order by Mr. Dennis Huey, Chairman, followed by the Pledge of Allegiance. Mr. Huey moved to waive the reading of the minutes of March 14th, 2007 and approve them as presented; motion seconded by Mr. Darrell Ensman; all yes. Copies of the minutes were available.

CORRESPONDENCE: 1) Pinney Dock sent a list of stone price quotes. 2) The Ashtabula County Engineer sent a quote for the cost of the Green Road reconstruction for the Kingsville Township end. The quote is \$243,615. 3) LE Construction Company sent quotes for a total of \$21,149 for the Mill Street and Creamer Road guardrail projects. 3) The Citizens for Community Values sent information regarding a bill being filed with the Ohio General Assembly to place two regulations on all sexually oriented businesses 4) Ashtabula County Health District annual report was received 5) Ashtabula County Engineer sent the OPWC pre-app forms 6) The ACE sent a letter addressing the Mill Street bank erosion being caused by people dumping leaves, grass and tree trimmings over the bank which is inhibiting the natural vegetation necessary to control erosion.

PUBLIC COMMENTS OR CONCERNS: None.

OLD BUSINESS: 1) Discussion ensued on the guardrail quotes. 2) Neal discussed the ACE letter regarding the dumping on Mill Street and how it is inhibiting the natural vegetation

NEW BUSINESS: 1) Neal brought up for discussion the issue of the proposed paving projects of S. Wright Street and Walton Hill Allotment. This issue was tabled 2) Neal advised that he learned that North Kingsville village was quoted a cost for hot asphalt paving at \$140 per ton by Koski. 3) Fire Chief Chip Laugen advised that they had to have a new tire put on Unit # 601. 4) Jim Branch reported that he issued one zoning permit and filed for a Conditional Use permit. 5) Jim also said that regarding the LeRoy Good property, he will need to have the Building Department declare the structure uninhabitable and the Health Department address the junk issue. 6) Jim also was advised of the situation on the corner of Wright St. and SR 84, property owned by Bob and Sue Cline. The roof has caved in on one building. He will send them a letter regarding the hazard this poses. 7) Mr. Reed moved to proceed with the guardrail installation for the Mill Street # 1 and # 2 quotes total of \$10,548 to be taken from the Permissive Motor Vehicle License Tax Fund; motion seconded by Mr. Ensman; all yes. 8) The OPWC Green Road project has been tabled. Mr. Huey will set up a meeting with the Ashtabula County Commissioners to see if they will be willing to help financially with this project.
