## November 26, 2014

Darrell Ensman, Chairman, called the November 26, 2014 regular meeting of the Kingsville Township Trustees this was followed by saying the Pledge of Allegiance. Doug Reed made a motion to waive the reading of the November 12, 2014 regular meeting minutes and approve them as presented. Dennis Huey seconded the motion; all yes. Copies of the minutes were available.

**CORRESPONDENCE**: 1) The township received from OTARMA Board of Elections a proxy ballot to vote for 2 candidates. 2) The fiscal officer received a message from Sam Howard of 5304 S Wright Street regarding the logs that are still in the park. Neal will call him. 3) The fiscal officer received a call from Tom Steele, Fire Chief of Ashtabula Township, Dennis Huey's telephone number on the letter that was sent to him was incorrect. The fiscal officer left him a voice mail with the correct one.

## PUBLIC COMMENTS AND CONCERNS: None

**OLD BUSINESS:** 1) Doug Reed reported that he still has not heard back from Koski Construction regarding the unfinished work that needs done, he said that he even left the message that the check for them has been cut and is being held until the work is complete. The trustees asked that the fiscal officer send a letter to them asking them to contact any of the trustees or Neal Stewart, Road Superintendent about unfinished work and overage charges. 2) Unit #609 is at Gainers and it needs tow hooks added to the back, they have two in the front but they would not be able to hook to the back if we need to be pulled out of anything from the back. 3) The logs that could be sold in the park have been picked up with the help of Sam Rettinger and the township will be receiving a check for them at a later date. 4) The new under carriage pressure washer is up and running as of today. They have not had much of a chance to use it yet but Neal thinks that it is a great purchase. 5) Jim Branch, Zoning, asked if the township had mowed 2997 Priest Street because the selling agent wanted to know if there would be a bill from the township. Neal said that they had not. He said that he will be working on the neon sign issue at Grab n Go and also checking to make sure that no one is living in the camper trailers on Reed Road. Neal reported that the township mowed on Dibble Road once and Donna Drive and Route 193 twice. He will get with the fiscal officer to submit actual hours so that the fiscal officer can send out the bills to property owners. 6) Deb's Tree Farm has donated the tree in the park gazebo. The trees will be cut tomorrow and they will have one ready to be picked up on Friday. Dennis or the road department will pick it up. 7) Tom Steele, Fire Chief for Ashtabula Township did get a hold of Dennis and Ashtabula Township's regular meetings are at 6:00 pm the same night as Kingsville's. Dennis will be attending the meeting on behalf of Kingsville. 8) There is still no electric at the cemetery.
