

# KINGSVILLE TOWNSHIP TRUSTEES REGULAR

November 23, 2015

Dennis Huey, Chairman, called the November 23, 2015 Kingsville Township Trustee regular meeting to order followed by the Pledge of Allegiance. Darrell Ensman made a motion to waive the reading of the November 11, 2015 regular and the November 18, 2015 work session meeting minutes and approve them as presented with the correction of the spelling of trusses not tresses. Dennis Huey seconded the motion; all yes. Doug Reed was late to the meeting due to his work schedule. Minutes were available.

**CORRESPONDENCE:** 1) The fiscal officer read a letter from Ohio Department of Public Safety regarding gratis license plates. The township verified that we were not using these plates for none township use.

**PUBLIC COMMENTS AND CONCERNS:** None

**OLD BUSINESS:** 1) Unit #609 is still at Champion Ford for repairs. 2) Dennis Huey reported that the Engineers Office is going to contact ODOT regarding the sidewalk from the school to the corner of Rts. 193 and 84 to see if the county or ODOT is responsible to spear head any repair/replacement projects. The sidewalks are in the road right of way. 3) Dennis Huey reported that he has not had any contact with Janet D, Commissioner's Office, regarding the South Wright Street property that is in very bad repair. Dennis will get in touch with her. He wondered if there is running water to the house. 4) A discussion was held regarding 2016 mowing. The township would like to have a couple of retired people to start in April or May and then have the teenagers for the summer as available. They thought that we should contact the local churches and ask if they could place it in their bulletins or make an announcement.

**NEW BUSINESS:** 1) Dennis Huey made a motion to do a resolution for accepting the amounts and rates as determined by the Budge Commission and authorizing the necessary tax levies and certifying them to the Ashtabula County Auditor. Darrell Ensman seconded the motion; all yes. 2) Scott B reported that Neal was off work until next Monday due to a sprained neck. The fiscal officer asked if it was work related because she had not heard anything from Neal. He said that he was not sure. The fiscal officer will follow up. 3) The floors for the salt shed have been poured and the trusses will be ready to set in about 3 weeks.
