Good afternoon,

For the last 3 weeks, I used 28 hrs of vacation. My comp balance is 96.64 hrs. Jim used 2.5 hrs of his free day you offered him at the beginning of July.

Jim and I have both been mowing in Lulu. I've tried to keep the yard mowed at the garage. Jim has been doing all the other mowing and weed eating. I filled some of the holes in Lulu. Two were from the trees that uprooted earlier in the year. The rest were sinking graves. Footer orders are due by the end of the month. So far, we have 3.

Mark Degan and I installed tile and a catch basin on Buie. We ditched on Hines Rd. I picked Mark up from Diaz Spring, in Erie, and took him back the following week. He had to take the black Mack for new springs. I helped him replace a couple of signs.

I took down the "Fresh Tar" & "Loose Stone" signs. I helped Karl finish the OPWC disbursement request for Dibble Rd. I helped Mike DeFazio hang 2 banners. I got a complaint about excessive traffic on Fox Rd., due to the closure of South Ridge.

The F550 was serviced. I replaced a broken light and wired in a new trailer plug. The old plug was severely corroded and causing a short between the reverse beeper and the running lights. It has just over 60,000 miles on it. The brakes need to be changed, they are original. It also has play in the right hand lower ball joint. I called 4 places for quotes. Greg Sweet is \$1820. Country Auto & Marine is \$1660. This is for a complete set of pads and rotors, and the ball joint, with labor. There may be additional charges if it is discovered we need additional parts, such as calipers, bushings, or brackets. Greg Sweet also recommends an alignment at a cost of \$140. Country Auto said we shouldn't need an alignment since it's a lower ball joint. He has an alignment rack, but said our truck is too big for it. Phil's Garage and Watson's didn't respond.

Jim changed the knives on the roadside mower. I'm looking into a price for the brush hammers for the mower.

At the Fire Department:

- 1) The foamboard got put up. We passed our insulation inspection.
- 2) The drywall is up and the first coat of mud is on.
- 3) The cabinets are ordered.
- 4) Paint and countertop choices have been selected.
- 5) Zeigler is going to rework the HVAC ducts.
- 6) None of the plumbing inside is hooked up. The water is still off.

Yard waste was emptied 6 times. I got lumber and built barricades for the yard waste site. Jim Branch provided signs. We closed the site on the morning of the 1st. There have been several people who have complained, including a guy who brought a trailer load of tree limbs from Conneaut. A few people have dumped in the Cemetery and in the back of the yard at the Garage. Jim Evans put up road closed signs behind the garage. If we continue to have an issue, I can put the camera up in the Cemetery. I've been doing some research on options for future yard waste. The attached quote is what it would cost us to have roll off boxes shipped to Brobst, like Ashtabula Township does. Also included are prices for Brobst to come here and pick up material. I haven't found anyone to do curbside pick-up. In asking around, I've discovered that pick-up is the best way to control how much, and what, we bring in. Ashtabula City offers pick-up 4 times per year. Residents must make an online reservation to get picked up. Either way, unless the Trustees, or others, are willing to volunteer, we don't have the manpower to effectively provide that service.
