It is understood that the group or organization using the above designated facility/park will comply with the laws of the State of Ohio, the

Township of Kingsville and all rules and regulations set forth by Kingsville Township and:

1. Will be responsible for all persons in the group or organization using the facility/park.
2. Assumes liability for any damage done to the facility/park.
3. There shall not be any grease-producing products cooked in the kitchen area of the Fire Hall building.
4. Will park ONLY in designated areas.
5. Will observe all rules posted.
6. There shall be ***no alcoholic beverages in or on the facilities and no smoking in the Fire Hall.***
7. Only local and emergency calls (911 calls) are to be made from the Fire Hall.
8. Will observe meeting room capacity. Meeting room capacity is 20 using tables and chairs and 30 using chairs only.
9. The Ashtabula County Sheriff's department has authority to enter the meeting room or patrol the park at any time to check for violations.
10. We agree to leave the facility/park in the condition that it was found and we assume financial responsibility to repair any and all damages as a result of our use or misuse of the property/facility **including the removal of all trash from the property that you produce.**
